We had a good review of The Glade's Reach 4A and 4B Preliminary Plan and walked the stream divided into two groups last Saturday (March 7). On **Saturday, March 28, 9:00 AM**, we plan to have another Preliminary Plan and Stream Review at the Pavilion (rain or shine – as the Pavilion is covered), located at the corner of Steeplechase Drive and Triple Crown Road (see attached map), before the DRB Review of the Preliminary Plan. Based on several comments, we will limit the Question and Answer session in the morning so that more time can be spent walking the stream and discussing the work. We will then return to the Pavilion to have lunch and answer additional questions for those who are interested.
