We invite you to join us for the first review of the Final Plans for Reaches 4A and 4B of The Glade stream:

Location: The Pavilion at the Corner of Steeplechase Drive and Triple Crown Road

Time: 9:00 AM – 2:00 PM (earlier if rain precludes walk)

Date: Saturday – May 9, 2009

Reach 4A starts at Steeplechase Drive and ends just downstream of the unnamed tributary coming from Saint John Neumann Catholic Church. Reach 4B starts at the downstream end of 4A and continues downstream to Soapstone Drive. A map of this area is attached to better illustrate the subject reach.

The purpose of this meeting is to:

- 1. Show you the Final Plans that reflect the final design that has incorporated citizen comments received to date as a result of the Preliminary Plan process.
- 2. Walk the streams (be prepared for stickers, mud, and walking in water) and access areas to visualize them in conjunction with the Final Plans. The limits of clearing will be flagged in advance, as well as all the trees proposed to be removed.

In addition to inviting you to the Reach 4 Final Plan Review, we also wanted to provide you with a revised schedule for community meetings for Reach 5. In summary, meeting dates have been pushed back approximately one month in order to resolve a scheduling conflict with a Reach 4 meeting. The revised schedule for Reach 5 is enclosed.
