- Reach 13: 30% complete. (Tributary 1 and drainage improvement are complete)


The Glade

UPDATE: OIL SPILLS SNAKEDEN REACH 2

Waste Cooking Oil Spill

- July 24th Buffalo Wild Wings was sited for discharge into stream.
- Atlas Environmental contracted by DEQ to clean

Heating Oil Spill

- Leak from Reston Community Center's underground storage tank (identified July 22nd)
- Apex contracted by DEQ to contain leak – installed booms and absorbent cloths in stream.








UPDATE: GLADE REACH 3 CITIZEN REQUEST TO RAISE TRAIL OUTSIDE LOC

- John Welsh requested that RA raise the trail, remove existing pipe, and create a drainage swale at area identified in red.
- RA approved request as part of normal maintenance.
- WSSI is afraid to proceed without DRB approval as work is outside of LOC.

RE: Stream Restoration Modification - Hunters Woods

Dear Mr. Butler:

A simple, inexpensive modification to the restoration plan would solve a problem that has existed for over 30 years! Just north of the bridge at the junction of Reaches 2 & 3 (station 25 + 50 on the Wetlands' plan) was a low point on the existing (now destroyed) paved walkway. After every heavy rain, water collected on the path and in the woods on each side. In the winter, this water often turned to ice, creating a major safety hazard on the path. For most of the time, the trees next to this low point have been trying to live in a swamp.

I recently met with John Connelly from Wetlands and proposed the following changes to the plan to address this ongoing problem.

- 1) Raise the paved walkway elevation (when rebuilt) so that the grade at the north end of the new bridge is maintained until it meets the existing grade near the intersection (about 100°). This will keep the new walkway dry and prevent excessive water from collecting in the woods east of the walk.
- 2) Create a short swale (about 50') along the west side of the walkway, starting at the low (swampy) area and discharging into the creek near the NW corner of the new bridge. This will eliminate the swampy condition and save the trees west of the walk.
- 3) Remove the existing section of small concrete pipe at the NW corner of the bridge, which often gets clogged up with sticks and leaves. This will ensure a natural, unobstructed flow from the new swale into the creek.

I understand that John Connelly has discussed these modifications with you. He suggested that I write this letter requesting your approval and support.
