We invite you to join us for the first review of the Final Plans for Reaches 5 and 6 of The Glade stream:

**Location:** The Basketball Court off of Hunting Horn Lane (see attached map) – we will

have a tent and tables set up on the court for plan review and a lunchtime

cookout.

**Time:** 9:00 AM – 2:00 PM (earlier if rain precludes walk)

**Date:** Saturday – September 12, 2009

Note – If you can't make this one, there will be a second meeting on 9/26 (same time and place).

Reach 5 starts at Soapstone Drive (across from the fire ring) and ends just upstream of the beaver area. Reach 6 starts below the beaver area and continues downstream to Twin Branches Road. A map of this area is attached to better illustrate the subject reaches.

The purpose of this meeting is to:

- 1. Show you the Final Plans that reflect the final design that has incorporated citizen comments received to date as a result of the Preliminary Plan process.
- 2. Walk the streams (be prepared for stickers, mud, and walking in water) and access areas to visualize them in conjunction with the Final Plans. The limits of clearing will be flagged in advance, as well as all the trees proposed to be removed.

In addition to inviting you to the Reach 5 and 6 Final Plan Review, we also wanted to provide information on future project notifications. Due to complaints to RA about the volume of mailings (which was a requirement imposed upon Northern Virginia Stream Restoration, L.C. by the Design Review Board in response to citizen requests), future mailings concerning stream restoration will only be sent to the owners of property adjacent to the affected reaches and to registered affected parties.
